The IMC Syllabus

The level 4 Investment Management Certificate (IMC) is one of the most widely recognised and established qualifications in the UK. The IMC is administered by the CFA Society of the UK and is approved by the Financial Services Authority as a threshold competency.

Currently held by over 15,000 professionals, the IMC is the investment industry's benchmark qualification of choice for those working in, or wishing to work in financial analysis and investment management. IMC candidates come from a diverse background and the exam is considered appropriate for anyone entering an investment-related role.

The IMC also provides the ideal foundation for those with future plans for the CFA® Program. IMC candidates cover some 30% of the CFA Level I curriculum. From induction to Masters level, the IMC-CFA route provides a globally recognised career progression for investment professionals that will provide long term benefit to both the delegates and their employers.

IMC Programme

The IMC consists of two units, each examined separately. Both units must be completed to be awarded the IMC qualification.
